### NOTICE OF PROPOSED ADOPTION OF THE LINCOLN COUNTY COMPREHENSIVE PUBLIC NUISANCE INVESTIGATION & ABATEMENT ORDINANCE

On Thursday, February 23, 2017, the County Commission of Lincoln County, West Virginia gave notice to the public on the County Commission's regularly maintained and published "Meetings Agenda" Website, <http://www.lincolncountywv.org/CountyCommission/MeetingAgenda/tabid/134/Default.aspx>, that the Lincoln County Commission would consider at its Special Session on Tuesday, February 28, 2017 at 9:00 a.m. at the County Commission's Chambers at the Lincoln County Courthouse in Hamlin, WV the introduction of the proposed **LINCOLN COUNTY COMPREHENSIVE PUBLIC NUISANCE INVESTIGATION & ABATEMENT ORDINANCE** for consideration by the County Commission, and the opening of a period of public comment on the proposed Ordinance. This same notice advised the public that the proposed Ordinance may be viewed at, and copies of the proposed Ordinance obtained at, the Office of the Lincoln County Clerk, Lincoln County Courthouse, Hamlin, WV.

**PLEASE TAKE NOTICE** that at its Special Session on Tuesday, February 28, 2017, the Lincoln County Commission introduced for consideration for adoption by the Lincoln County Commission a proposed **LINCOLN COUNTY COMPREHENSIVE PUBLIC NUISANCE INVESTIGATION & ABATEMENT ORDINANCE**. This proposed Ordinance would, by establishing definitions, declarations and procedures for investigating and abating public nuisance activities or conditions, implement within Lincoln County, WV the authority conveyed to the Lincoln County Commission West Virginia Code Sections 7-1-3ff and 7-1-3kk to declare, prohibit and abate public nuisances within Lincoln, and to adopt ordinances to protect the public health, safety, welfare and the environment within Lincoln County from actual or threatened public nuisance conditions or endangerments to the public health or safety.

**PLEASE TAKE FURTHER NOTICE** that the Lincoln County Commission has scheduled two (2) separate future Hearings before the Lincoln County Commission to Receive Public Comment on the proposed Ordinance. The Public Hearings to Receive Public Comment on the proposed Ordinance have scheduled to commence at **5:50 p.m. on Thursday, March 2, 2017** and at **5:50 p.m. on Thursday, March 16, 2017**. Both Public Hearings will take place at the Lincoln County Commission Hearing Room at the Lincoln County Courthouse, Hamlin, WV.
